Sub: First Appeal preferred by Shri Pradeep Shah under RTI Act, 2005- regarding.


Whereas Shri Pradeep Shah vide his RTI application dated NIL(received in this Ministry on 05/05/2014) had sought information from the Ministry of Home Affairs regarding details of some false and malicious complaint letter concerning Sri Vidya Samiti Malakar, Kerala sent to MHA by 'Padmapada' in 2010.

2. Whereas CPIO vide his letter No. 43020/01/2014-RTI dated 16/05/2014 had already replied to the applicant that it is not clear as to what specific information is required by the applicant.

3. Whereas Shri Pradeep Shah vide his appeal dated 26/05/2014 (received in this Ministry on 02/06/2014) has reiterated his RTI application and has asked for required information.

4. Whereas Shri Pradeep Shah is informed that under the Right to Information Act, 2005, an applicant can seek that information from Public Authority which exists in the records and is held by/under the control of that public authority. It is not clear from his RTI application and appeal as to whether the complaint was made to MHA and if so, on what date. He has also not explained about the details of complainant or the complaint to enable this Ministry to identify the repository of the information. Hence, no information can be supplied. Therefore, the reply given by the CPIO is in order.

5. The Appeal of the appellant is accordingly disposed of without any order.

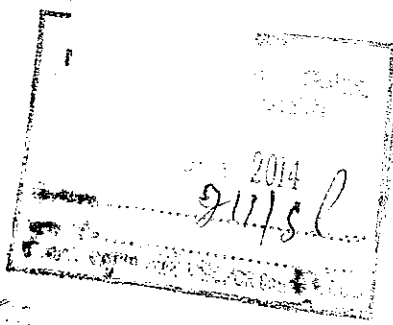
