



1. Please supply the certified copy of the **note portion** of the file bearing No. 14033/23/99/UTS -II.
2. May peruse letter No. 14046/31/2008-UTS-II dated 21 June, 2010 from B. Bhamathi, Additional Secretary (UT) & Appellate Authority (Copy enclosed). Note portion of the above file was refused to be supplied on the grounds that Hon'ble High Court, vide its interim order dated 5<sup>th</sup> November, 2009 in WP(C) No. 11465/2009 had stayed the impugned order of Central Information Commission, wherein the SP's report was disclosed and in view of the stay order of the Hon'ble Delhi High Court, at that stage, SP's report could not be disclosed. Since, file nothings of the concerned file had excerpts of the SP's report, the same could not be provided.
3. WP (C) 11465/ 2009 and CM No 11194/2009 filed by CBI has been disposed of as withdrawn. Copy of the order of Hon'ble High Court of Delhi dated 31<sup>st</sup> May 2011 is enclosed. Thus difficulty in supplying the note portion of the file has been removed by High Court
4. SP report referred to in letter dated 21 June, 2010 ( Para 3) as above has been supplied to me vide order dated 29.04.2011 of Hon'ble High Court of Delhi in Cr./MC 448/2009 (Copy enclosed).
