

1	Copies of the relevant noting portion and correspondence with DoP&T will be provided after receiving a payment of Rs. 38/- (19 pages @ Rs. 2 per page).
2	Copy of the note for the JCA with other relevant papers, will be provided after receiving a payment of Rs. 624/- (312 pages @ Rs.2 per page).
3	Adequate notice for the JCA was given. The requisite documents are proposed to be provided against point No.2.
4	Copy of the notification regarding the constitution of JCA, will be provided after receiving a payment of Rs. 4/- (Two pages @ Rs.2 per page). Chief Secretary, Mizoram was not present in the JCA meeting held on 16.07.2014. Minutes of the meeting proposed to be provided against point No.6 contain the proof of attendance of members.
5	In the meeting held on 16.07.2014, the JCA decided the transfer/ posting of the IAS/IPS officers of AGMUT cadre taking the Guidelines on Transfer and posting of IAS and IPS officers of AGMUT cadre and all other relevant factors into consideration.
6	Copy of the minutes of the meeting of the JCA of the AGMUT cadre, held on 16.07.2014, will be provided after receiving a payment of Rs. 14/- (seven pages @ Rs.2 per page). Minutes were finalized immediately on conclusion of the meeting. Therefore, draft minutes are not available.
7	The postings and transfers are done taking in mind the administrative requirements of all the segments of the AGMUT cadre. Minutes of the meeting of the JCA of the AGMUT cadre held on 16.07.2014 are proposed to be provided against point No. 6.

As regards the documents relating to the decision taken in each case, the RTI application is being transferred to DoP&T for providing the requisite information directly to the applicant.



2. PARTICULARS OF INFORMATION SOUGHT:

1. Is it correct that there is a proposal for reconstitution of the JCA for AGMUT cadre? If it is correct, then copies of the correspondence along with noting portion, made with DoPT till date may be provided.
2. Is it correct that the meeting of the Joint Cadre Authority that was called by the Ministry of Home Affairs on July 16, 2014 was without any clear and written agenda? If it is not correct, then copy of the agenda be provided. If it is correct, the copies of the note sheets on which the proposal for calling JCA was taken, be provided.
3. Is it correct that meeting of the JCA was called in a hurry to address selected cases of transfer of IAS and IPS officers? If it is not correct, the list of officers and details of their postings, station seniority age, scale etc. that was placed before the JCA, be provided.
4. Is it correct that JCA was not fully represented? If it is not correct, copy of the order relating to constitution of the JCA be provided along with attendance sheet of the members who were present in the JCA.

5. Is it correct that JCA meeting on 16/07/2014 decided the transfer of officers without following any objective criteria and without following the existing Guidelines on Transfer and posting of IAS and IPS officers of AGMUT Cadre?

6. Is it correct that discussions in the meeting of the JCA were not recorded neither in detail or case-wise? Copy of the draft and fair minutes of the JCA be provided.

7. Is it correct that in violation of the existing Guidelines on transfer/postings of IAS and IPS of AGMUT, interests of the direct recruit IAS/IPS officers were considered, ignoring promotee IAS officers of AGMUT? If it is not correct, details of the reasons as recorded in case of promotee IAS and IPS officers transferred vide order dated 18.7.2014 be provided.

8. Is it correct that IAS and IPS officers of other cadres have been posted in GNCTD. If it is correct, all documents relating to the decisions taken in each such case be provided along with copies of the relevant note sheets.
