



Subject: First Appeal filed by Shri Harpal Singh Rana under the RTI Act, 2005.

Whereas Shri Harpal Singh Rana had addressed his application to the Govt. of NCT of Delhi which was subsequently transferred by the Lt. Governor's Secretariat to the Ministry of Home Affairs for providing information in respect of queries No. 6 to 8.

2. Whereas it was observed that Shri Rana had not sought any specific information that was available in the Ministry of Home Affairs. He had sought reasons/logic for naming the residence of the Hon'ble Lt. Governor as 'Raj Niwas'. Since such requests are not covered under the definition of 'information' defined under Section 2 (f) of the RTI Act, 2005, the CPIO vide his letter dated 25/11/2013 had informed the applicant about the inability to provide any information.

3. Whereas the appellant has filed his First Appeal dated 17/02/2014 under the RTI Act, 2005 which was received in the Ministry on 19/02/2014. Therein he has requested this Ministry to provide information which was sought in the application.

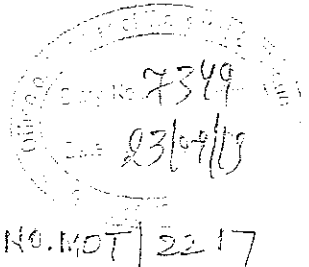
