- Whereas it was observed that Shri Rana had not sought any specific 2. information that was available in the Ministry of Home Affairs. He had sought reasons/logic for naming the residence of the Hon'ble Lt. Governor as 'Raj Niwas'. Since such requests are not covered under the definition of 'information' defined under Section 2 (f) of the RTI Act, 2005, the CPIO vide his letter dated 25/11/2013 had informed the applicant about the inability to provide any information.
- Whereas the appellant has filed his First Appeal dated 17/02/2014 3. under the RTI Act, 2005 which was received in the Ministry on 19/02/2014. Therein he has requested this Ministry to provide information which was sought in the application.
- Whereas Shri Harpal Singh Rana is informed that he had not sought 4. any specific information under the RTI Act, 2005 which was available with/held by the CPIO in a physical form. Since the queries seeking logic/reasons of the public authority did not come under the scope and ambit of the RTI Act, 2005, no information could be provided. Thus, the reply of the CPIO was in order.
