1. Grade Pay fixed after the implementation of 6 <sup>th</sup> Central Pay Commission in cases of officials of Ministry of Home Affairs, who were in the pay scale of Rs.6500-10,500/-	After implementation of 6 <sup>th</sup> CPC recommendations, the pre-revised scales of Rs.5000-8000, 5500-9000 and 6500-6900 & 6500-10500 were replaced by a single pay band, PB-2 (Rs.9300-34800) with Grade Pay of Rs.4200/-. Accordingly, the Grade Pay of Rs.4200/- has been fixed. Later on, for Assistants who were earlier in the pay scale of Rs.6500-10500 in the pre-revised scale, Grade Pay has been revised to Rs.4600/-
2. Copy of the Noting examining the pay fixation of officials of the Ministry of Home Affairs who were in pay scale Rs.6500-10500 after implementation of 6 <sup>th</sup> Central Pay Commission.	Pay of all the Assistants were fixed as per the provisions under 6 <sup>th</sup> CPC. If any specific case is pointed out, the same will be made available.
3. Copy of at least 02 (two) pay fixation orders issued after examination/vetting.	Two pay fixation orders are enclosed.
4. Copy of the relevant rules/policy letter on the basis of which pay fixation was done in these cases.	Pay was fixed as per Central Civil Service (Revised Pay) Rules, 2008. The said rules are in the Website of Ministry of Finance.
