I am Venkata Krishna Kumar Vullaganti s/o V.V.N Rao aged 32 years Occupation Software Engineer working in Infosys Ltd., Gachibowli, Hyderabad. I am having 2 mobile number 80008123851 (Airtel Postpaid) & 9502745376 (BSNL Postpaid). I have been using these numbers for many years.

I had been facing lot of disturbances, interceptions, sudden call drops during some threats. I am having life threat from some unknown persons for many years. Many attempts on my life happened so far. Some persons had thrown rocks and broken my car glasses etc. These things were happened after made some insurances against me by parties of my estranged wife side. Especially during threat times, i was unable to made mobile calls due to sudden signal drops. Its very evidential that there are some persons are tacking and communicating my moves.

In addition to this, I had submitted complaints and petitions and defending against my illegal arrest, defamation and subsequent remand violations bring up to the appropriate forums. They are all pending. There are some instance that some CID police of AP had taken my mobile also. I had been facing police harassment from some unknown persons along with some police officials due my lokayutha cases which disclosed many violations of my arrest, remand, wrong jurisdiction, forged documents in court, back dated evidences etc.
