



The President is pleased to accept the recommendations made by the VIth Central Pay Commission in Para 4.2.73, 74, 76 & 81 of the Report and to revise the rates of Uniform Allowance, Renewal Grant, Kit Maintenance Allowance and Washing Allowance in respect of CPMF personnel and Clothing Allowance/Annual Renewal Grant in respect of IB personnel as follows w.e.f. 1.9.2008:-
