Whereas Ministry of Minority Affairs vide their letter No.14/132/2013-Wakf dated 12/12/2013 transferred the RTI application of Shri Apurbo Chakraborty dated 31.10.2013 regarding his complaint against Kotkalli Ram Swamy Muddaigauda alias Swamiji, Chembur, Mumbai.

2. Whereas CPIO vide his O.M No. A 43020/01/2014-RTI dated 15.01.2014 intimated the Ministry of Minority Affairs that the issues raised in the application have no relation to the functioning of this Ministry and the transfer of the above application was not accepted. A copy of the letter was endorsed to the applicant.

3. Whereas Shri Apurbo Chakraborty vide his appeal dated 18/03/2014 (received in this Ministry on 24/03/2014) has stated that he has not been supplied with the satisfactory information and requested to issue the order for giving him the requisite information.

4. Whereas the appellant is informed that the issues raised in the application is about a local criminal which did not come under the purview of the Ministry of Home Affairs but was related to State Police. Since this Ministry had not accepted the transfer of the application and returned the same to the Ministry of Minority Affairs, the question of filing the first appeal to this Ministry does not arise.

5. In view of above, the appellant is informed that the action of the CPIO seems to be appropriate. The appeal is accordingly disposed of.





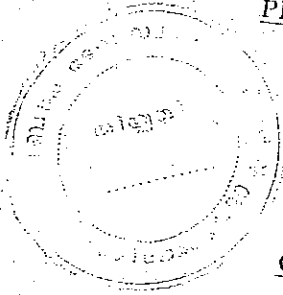

सन १९९६ मध्ये श्री अपूर्व चक्रवर्ती हा पांजरापोळ शनिमंदीर येथे दर्शनासाठी आलेले होते. त्यावेळी त्याने माझे व्हिजीटिंग कार्ड घेतले आणि तो दर्शन घेवु निघुन गेला त्यानंतर तो रोज मला रात्री देराडी फोन करून सांगु लागला की, मेरा काम नही हो रहा है मेरा दिन बहुत खराब चल रहा है तसेच मेश ओरलत मुझे छोड दिया है, मेरा भाई, बहीण मेरे साथ बात नही करते है, मेरा फिल्म लाईन एक्कदम खराब चला रहा है असे सांगितल्यानंतर मी त्याला आम भगवानसे दुवा करो आपका अक्ल हो जायेगा असे मी त्याला सांगितले. तरीही अपूर्व चक्रवर्ती हा वारंवार फोन करून यास देत होता. म्हणुन मी त्यास तुम्ही पुजा शनिमंदीरात करून टाकतो असे सांगितले त्यानंतर तो त्यांचा भाऊ नामे अंजय यांच्यासह शनिमंदीर येथे पुजेसाठी आले होते. सदरवेळी त्याने मला ६००/- रूपये दिलेले होते. मी अपूर्व चक्रवर्ती यांची नऊ मटक्याची शनिमंदीरात पुजा करून नऊ मटकी त्यांच्या अंगावरून उतरवून समुद्रात पाण्यात टाकून आलो. सदरचे छोट्या नऊ मटक्यामध्ये वेगवेगळ्या प्रकारचे धान्य व हाळद कुंकु मटक्यामध्ये धान्यावर टाकलेले असते. त्यानंतरही दोन तीन वेळा अपूर्व चक्रवर्ती यांने मला फोन करून सांगितले की, मेरा काम नही हो रहा त्यावेळी मी त्यास भगवान के उपर भरोसा रखो असे सांगितले. त्यानंतर दोन तीन वेळा अपूर्व चक्रवर्ती हा शनिमंदीर पांजरापोळ या ठिकाणी दर्शनासाठी आलेला होता.

सन २००८ मध्ये याच विषयी तक्रार अपूर्व चक्रवर्ती यांने माझे विरोधात ट्राम्बे पोलीस ठाणे येथे केलेली होती. त्यावेळीही पोलीस उप - निरीक्षक हजे यांनी माझा जबब नोंद केलेला आहे. अपूर्व चक्रवर्ती यांनी माझेवर ज्या प्रकारचे आरोप केलेले आहेत ते जर सत्य मानले तर मी देव देवता बरोबरचा झालो असे मानावे लागेल अधुनिक जगात असे प्रकारच्या अंधश्रध्दाव विश्वास ठेवणे म्हणजे मूर्खपणाचे लक्षण आहे.


