- e) Please provide detailed information about the preventive measures taken by Election Commission of India in the regard.

I am in receipt of reply by the Election Commission of India vide reference no.4/RTI/73/2013-EPS/522 dated:11/12/2013 in which they said that the required information are not available with them and the same may be available with the Ministry of home affairs; therefore I am requesting you to please provide the abovementioned information.
