

Sub: Seeking information under RTI regarding collection of funds in the name of Wive's Welfare Association activities & its use.

Sir,

The Central Armed Police Forces like BSF, ITBP, CISF, CRPF, SSB and Assam Rifles are raising huge funds in the name of activities under the banner of Wive's welfare associations and misusing it on the entertainment of Senior Officers & other junior officers wives on kitty parties & running their club activities. In the name of such activities few officers and their wives are involved in earning money by way of selling their own products in mela and shops run by these associations in all CAPF.

It has also known to all that during organizing such mela by CAPF a large number of government resources like vehicles from all over India their officials & officers come to organize such mela and camps in Delhi and spend government money for assisting a NGO/Association of CAPF. The government and MHA keep silence even it happen every year. However the profit goes to such associations but 1000 times expenditure incurred on it born from government funds due to involvement of senior officers wives.

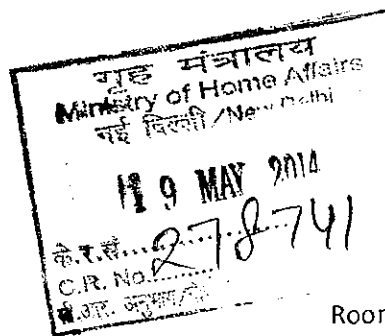
It is therefore requested that to know the misappropriation of government fund on the cost of earning of such associations the following information of last 5 years may please be intimated to me under RTI from all CAPF viz BSF, ITBP, CISF, CRPF, SSB and Assam Rifles:-

- 1- The earning of year & force wise of Wives welfare associations of all forces.
- 2- The earning of Mela year & force wise of wives welfare associations of all forces.
- 3- The no. of vehicles (LMV, Medium, Heavy separately) attended mela and other activities year wise and how much kilometer covered by each vehicles in last 5 years be intimated.
- 4- How many officials and officers detailed by the forces – the details of force and year wise be given with estimated expenditure on their TA & DA borne by the government.
- 5- How much amount have been donated in last 5 years by senior officers wives to wives welfare associations and how much gift they have accepted from the fund of such associations: details of year & force wise be given of last 5 years.
- 6- Force wise funds position as of now of their respective wives welfare association be intimated with its investment.
- 7- Force wise information on loss of investment, if any be intimated with amount & details of investing company till date.
