The proposal on the file relates to consideration of the representation submitted by Shri J.S.Negi, Ex-.Commandant, CISF, who retired from service prematurely under FR-56 (j).

- 2. The suitability of Shri Jagmohan Singh Negi, Ex-Commandant, CISF for his retention in service beyond the age of 50 years under FR 56 (j) was reviewed by an Internal Screening Committee. The ISC after considering all the relevant service records of Shri Jagmohan Singh Negi recommended for his pre-mature retirement from service (page 59-60/corr.). The Review Committee of MHA found Shri Jagmohan Singh Negi unsuitable for retention in service and agreed for his premature retirement from service under FR-56 (j) (page 26-27/corr.). Accordingly, with the approval of Hon'ble HM (page 23-24/corr.), Shri Jagmohan Singh Negi was retired prematurely w.e.f. 18.03.2010 (page 58/corr.).
- 3. Aggrieved with the above decision, Shri Jagmohan Singh Negi filed a Writ Petition in the Hon'ble High Court of Delhi which was dismissed, vide judgment order dated 18.05.2011 (page 12-16/corr.).
- 4. Meanwhile, Shri Jagmohan Singh Negi submitted a representation dated 08.04.2010 (page 1-4/corr.) addressed to President of India requesting therein to reinstate him in the service. Since Shri Negi filed a WP in the Hon'ble High Court of Delhi, CISF suitability replied Shri Negi (page 18/corr.) that action on his representation will be taken after disposal of the WP. The High Court dismissed the W.P.
- 5. Shri Jagmohan Singh Negi again submitted a representation dated 23.05.2011 (page 17/corr.) addressed to the President of India wherein he has requested to consider his earlier representation dated 08.04.2010. In his representation, he has raised following points:
  - i) Review Committee had not given due regard to the entire service record of his and confined itself to the period from 2<sup>nd</sup> January 2006 to 30<sup>th</sup> June 2009 when he was holding the rank of Commandant and posted at CISF Unit Farakka Barriage Project.
  - He was warned on five occasions during the above period but these are not sufficient grounds to retire him immediately in public interest.
  - iii) He was given many additional duties during the above period which he tried his best to complete and bring improvement in the administration.
  - iv) He was graded 'Average' in his ACRs during the above period. His representation against the above gradings have not been replied.

6. As required under the rules (page 68-81/corr.), a representation Committee comprising a nominee of Ministry of Information and Broadcasting (Shri Rajiv Takru, IAS, Addl.Secretary) and Secretary, Department of Industrial Development has been constituted with the approval of competent authority (page 19/N).

7. The representation Committee has gone through the representation & examined all relevant documents and found that there is sufficient justification to uphold the decision of the Review Committee in retiring the officer pre-maturely w.e.f. 18.03.2010 (FN). After a detailed discussion, the Committee decided to reject the representation of Shri Jagmohan Singh Negi, Ex-Commandant, CISF. The grounds mentioned by Committee for rejection of the representation are as follows:

- a) His ACR grading for the two periods as Commandant was average. This shows a clear deterioration on the grading of the earlier period. It is evident that Shri Negi has reached his level of incompetence, therefore it would not be in public interest to retain him in service.
- b) There is nothing in the representation of Shri Negi to suggest to explain the deterioration in his performance as reflected in the ACR grading for the period 2006-07 and 2007-08. The earlier entries relate to different subordinate posts held by Shri Negi and cannot be justifiably used to measure his performance for the higher post of Commandant. For assessing his retention in his service or otherwise, ACRs pertaining to the present post have to be considered.
- c) The representation does not allege that order was passed on mala fide grounds or it is a perverse order being arbitrary. A perusal of the order further shows that it is based on evidence in the form of ACR entries, DG's & IG's Displeasure and Warnings on 5 occasions.
- 8. The findings of the Representation Committee upholding the decision of the Review Committee and rejecting the representation dated 08.04.2010 and 23.05.2011 of Shri Jagmohan Singh Negi, Ex-Commandant, CISF seems logical & well reasoned and are placed before Hon'ble HM for acceptance/approval.





6. Shri Jagmohan Singh Negi was retired prematurely in the public interest because his performance was just satisfactory and he was holding the post of Deputy Commandant during 2<sup>nd</sup> July 2002 to 1<sup>st</sup> January 2005. Subsequently, after his promotion as Commandant, his performance was deteriorating and he was graded as an 'Average' officer for two years. He was also conveyed the displeasure of both the IG and the DG.

7. The petitioner's representation against below benchmark grading was submitted on 15.5.2010 to DG, CISF. This representation was rejected being devoid of merit after the competent authority had carefully considered his relevant representation, relevant documents and comments furnished by the appropriate authorities and found that there was credible material on record to reduce the grading endorsed in his ACR/APAR was based on the objective assessment by senior officers on his performance.

F.R.-56(j) is being reproduced below:-

"Notwithstanding anything contained in this rule, the appropriate authority shall, if it is of the opinion that it is in the public interest so to do, have the absolute right to retire any Government servant by giving him notice of not less than three months in writing or three months' pay and allowances in lieu of such notice:

- (i) If he is, in Group 'A' or Group 'B' service or post in a substantive, quasi-permanent or temporary capacity and had entered Government service before attaining the age of 35 years, after he has attained the age of 50 years;
- (ii) In any other case after he has attained the age of fifty-five years."
- 9. The issue under consideration is whether Shri Negi should be retained in service as Commandant in CISF or not. A perusal of the statement of ACRs in respect of Shri Negi shows that his grading for the two periods as Commandant was average. This shows a clear deterioration on the grading of the earlier period. It is evident that Shri Negi has reached his level of incompetence, therefore it would not be in public interest to retain him in service.

Deputy Secretary (Pers.I) & CPIO vide their ID No. 45015/02/2011-Pers.I dated 22.05.2013 (FR) has forwarded a copy of CIC order dated 08.05.2013 regarding providing of copy of the decision of the competent authority on the retirement to Shri J. S. Negi.

- In this context, it is submitted that on perusal of record available with us, it reveals that
- (i) R&W Section received a representation dated 03.09.2010 (p-71/c) addressed to the Secretary, Home Affairs, as a general public grievance and same was forwarded to CISF vide R&W Dy No. 114460 dated 22.09.2010 (p-63/c) for their comments.
- (ii) CISF forwarded their reply vide UO dated 29.11.2010 (p-74/c) without enclosing application dated 3.9.2010 of the applicant. Therefore, UO note was returned to CISF and requested that copy of application dated 03.09.2010 be placed on the file and suitable reply may be given to the applicant.
- (iii) CISF re-submitted the file vide UO dated 30.12.2010 (p-73/c), mentioning that......... The officers has also filed writ petition in the High Court of Delhi on the matter, which came up for hearing on 12.11.2010 and adjourned to 18.01.2011. (Refer page 73/c).
- (iv) Since Writ petition of the officer was under consideration before the High Court of Delhi, therefore, CISF was informed that necessary action on his writ petition will be taken, on receipt of decision of the Hon'ble Court on the matter. Accordingly, matter was closed by the US (PMA) being a general public grievance. (p-72/c). Based on above, CISF given reply to the petitioner on 27/01/2011 (p-70/c).
- it is pertinent to mentions here that original representation dated 8.4.2010 submitted by the Ex-Commandants J.S. Negi (addressed to the President of India), against his pre-mature retirement, was not received by R&W section. Only copy of the said representation was placed on the file by CISF while submitted reply on the representation dated 3.9.2010 on 30.12.2010 (p-64/c).

- However, representation dated 23.5.2011 submitted by Shri J.S. Negi, are dismissal of his Wirt Petition by the Hon'ble High Court of Delhi, to consider his earlier representation dated 08.04.2010 was required to be considered by the Representative Committee through Pers.I Branch, but was forwarded to R&W and the matter was closed "erroneously" by R&W Section based on the CISF note 30/12/2010 and earlier reply dated 27/01/2011 treated as a general public grievance. (p-64/c).
- 4. Based on above, CISF replied to the petitioner on 17/11/2011 stating that your representation dated 8.4.2010 and 3.9.2010 against premature retirement has been considered by the competent authority of MHA as per provision contained in the Rules and decided to close the matter. (p-36/c).
- 5. Later on, his representation dated 8/4/2010 and representation dated 23/5/2011 was placed before the Representation Committee on 5/7/2012 by Pers.I Branch and Representation Committee arrived at the conclusion that there is sufficient justification to uphold the decision of the Review Committee in retiring the officer pre-maturely w.e.f. 18.03.2010 (FN). Therefore, after a detailed discussion, the Committee decided to reject the representation of Shri Jagmohan Singh Negi, Ex-Commandant, CISF (p-56-57/c).
- 6. Since, case file is not available in R&W, therefore, we may request DS (Pers-I) that file may be obtained from CISF and suitable reply given to the applicant.

Submitted that Shri Jagmohan Singh Negi, Ex-Commandant, CISF was prematurely retired wef.18.03.2010 (FN) under FR-56(J) (2<sup>nd</sup> review). He had submitted a representation dated 08.04.2010 to the President of India. While his representation was under process, he filed a WP in High Court of Delhi. Hence his representation was kept in abeyance as directed by MHA(R & W) vide UO Note at (Page-19/Cor). The WP of Shri Negi has been dismissed by Court vide judgement order dated 18.05.2011 (Page-12 to 16/Cor). He submitted another representation dated 23.05.2011 wherein he had requested to consider his earlier application dated 08.04.2010.

His representation dated 23.05.2011 together with his earlier representation dated 08.04.2010 was forwarded to MHA along with Para wise comments (Page-06 to 10/Cor) vide this Dte. UO Note No. (1537) dated 27.06.2011(Page-01/N). Further required information/documents as asked by MHA were also submitted vide this Dte. UO Note dated 04.08.2011 (Page- 03/N ) for processing the case.

As asked for by MHA, a reconstructed file of the Ex-officer was submitted to MHA on 30.09.2011 and further required documents asked by MHA were also submitted vide this Dte. UO Note dated 11.10.2011(Page-07/N of reconstructed file). In this reconstructed file, MHA (R&W) had decided to close the matter vide note dated 27.10.2011 (Page-08/N of reconstructed file) and the same has been communicated to the Ex-officer vide this Directorate letter dated 17.11.2011 (Page-60/Cor).

After that the original case file of the Ex-officer (located by MHA in their own office) was received on 07.12.2011 from MHA/Pers.I with note "We may request CISF to intimate whether the representation of Shri Jagmohan Singh Negi, Ex-Commandant, CISF against premature retirement is to be placed before representation committee or otherwise. CISF may also furnish two case files of such Ex-officer, whose cases were placed before representation committee." (Page-8/N).

As such the earlier decision of MHA(R&W) given in the reconstructed file had already been communicated to Shri J.S.Negi vide this Directorate letter dated 17.11.2011 (Page-60/Cor). Hence, request was made to MHA vide this Directorate UO note dated 28.12.2011 to hold their earlier order of closure (Page-09/N).

But the MHA, vide their note dated 10.01.2012 (Page-09/N), has directed to process the representation of Shri Jagmohan Singh Negi, Ex-Commandant, CISF against pre-mature retirement for placing the case before the appropriate representation committee. Since, the MHA(R&W)'s decision of closure of matter earlier given on the reconstructed file had already been communicated to Shri Jagmohan Singh Negi, Ex-commandant, CISF and it would not here been appropriate to take another decision in this matter, the matter has been discussed on 22.02.2012 by JS(P-II) with IG(HQrs), CISF and it has been decided that the representation of Shri Jagmohan Singh Negi may be placed for consideration of the appropriate Representation Committee.

In view of above the representation dated 08.04.2010 of Shri Jagmohan Singh Negi, Ex-Commandant, CISF against pre-mature retirement alongwith parawise comments is submitted herewith for placing the case before the appropriate Representation Committee.

- 2. The suitability of Shri Jagmohan Singh Negi, Ex-Commandant, CISF for his retention in service beyond the age of 50 years under FR 56 (j) was reviewed by an Internal Screening Committee.
- 3. The ISC after considering all the relevant service records of Shri Jagmohan Singh Negi recommended him for pre-mature retirement from service under FR 56 (j) (page 59-60/corr.).
- 4. The Review Committee of MHA found Shri Jagmohan Singh Negi unsuitable for retention in service and agreed for his premature retirement from service under FR-56 (j) (page 26-27/corr.). The Hon'ble HM approved premature retirement of Shri Jagmohan Singh Negi under FR-56 (j) (page 23-24/corr.). He was retired prematurely w.e.f. 18.03.2010 (page 58/corr.).
- 5. Aggrieved with the above decision, Shri Jagmohan Singh Negi filed a Writ Petition in the Hon'ble High Court of Delhi which has been dismissed, vide judgement order dated 18.05.2011 (page 12-16/corr.).
- 6. Meanwhile, Shri Jagmohan Singh Negi submitted a representation dated 08.04.2010 (page 1-4/corr.) addressed to President of India requesting therein to reinstate him in the service. The matter was dealt with in R&W Directorate, MHA. The R&W Directorate, MHA informed CISF that since Shri Negi filed a WP in the Hon'ble High Court of Delhi, action on the same will be taken after disposal of the WP (page 19/corr.). CISF suitably replied Shri Negi (page 18/corr.).
- 7. Shri Jagmohan Singh Negi again submitted a representation dated 23.05.2011 (page 17/corr.) addressed to the President of India wherein he has requested to consider his earlier representation dated 08.04.2010. CISF vide their note at page 9/N stated that as per the directions to the effect that we may close the matter given by R&W Dte., MHA, CISF sent a reply to Shri Negi vide letter date-d 17.11.2011 (page 60/corr.).

- 8. CISF again requested this Ministry vide note at page 9/corr. to hold on the earlier decision given by MHA (R&W).
- In this connection, it is stated that the instructions on the subject 9. provides (page 55-57/corr.) that a Government employee who has been served with a notice/order of premature retirement under the provisions may submit a representation within three weeks from the date of service of such notice/order. On receipt of a representation, the Administrative Ministry/Department/Office should examine the same to see whether it contains any new facts or any new aspect of a fact already known but which was not taken into account at the time of issue of notice/order of premature retirement. This examination should be completed within two weeks, from the date of receipt of the representation. After such examination, the case should be placed before the appropriate Committee for consideration. representation from Government employees who have been served with a notice/order of premature retirement, but have obtained stay order (s) from a Court against the order/notice of premature retirement, need not be considered by the Administrative Ministry/Department or Office nor sent to the Committee until the disposal of the Court case. Thereafter, the cases may be examined as outlined above, also taking into account any material of a substantive nature that may feature in the Court judgement.
- 10. Keeping in view of the above, the case is required to be placed before the representation committee for consideration. We therefore, requested CISF to process the representation of Shri Jagmohan Singh Negi, Ex-Commandant, CISF against pre-mature retirement for placing the case before the appropriate representation Committee.
- 11. Now, CISF vide note at page 10/N have intimated that the MHA (R&W)'s decision of closure of matter earlier given on the reconstructed file has already been communicated to Shri Jagmohan Singh Negi, Ex-Commandant, CISF and it may not be appropriate to take another decision in this matter. 
