- 3. The order dated 14.11.2006 placing you under suspension was made under Rule 3(3) of the All India Services (Discipline and Appeal) Rules 1969. Further, your suspension was reviewed from time-to-time by the Central Ministry's Review Committee constituted under the Rule 3 (1) (C). As such, the order is valid and as per rules and regulations. Further, in terms of first proviso to Rule 3(1C) of the All India Services (Discipline and Appeal) Rules, 1969, the suspension of an IAS officer can be continued beyond 2 years on the recommendation of the Central Ministry's Review Committee. MHA constituted a Review Committee, which reviewed your suspension and recommended extension of suspension period for 180 days beyond 1.1.2014.
- 4. Further, inspection of file No. 14033/9/2006 may be done after seeking prior appointment from Shri A. K. Das, Under Secretary (UTS) /DCPIO.
