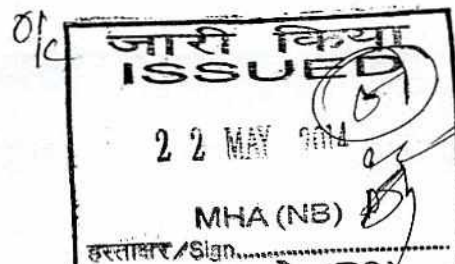
6. Your first appeal is disposed of accordingly.
