

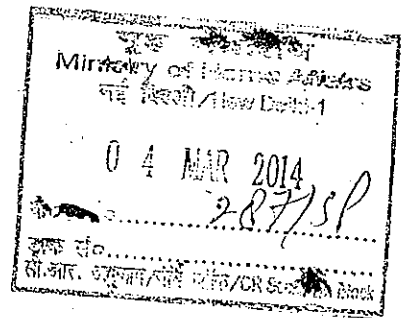

Dear Sir,

The undersigned, an associate professor at the Department of Mathematics, University of Delhi, would like to have the following documents:

1. Kindly provide me the copy of the Action Taken Report (ATR) by Sh. Sushil Kumar Shinde, Hon'ble Minister of Home Affairs on my complaint dated February 20, 2014 (once again enclosed herewith) against Ms. Sindhu Pillai (DCP-North) and Mr. Sandeep Goel (Joint Commissioner-Northern Range) for protecting the accused of sexual harassment, viz. Prof. Ajay Kumar (Department of Mathematics, University of Delhi) by way of not lodging an FIR of the undersigned under the influence of Prof. Dinesh Singh, Vice-Chancellor, University of Delhi. (Please be informed that the offence committed by the accused, viz. Prof. Ajay Kumar invokes the Sec. 354 and 509 of the IPC and there is a Supreme Court ruling that the FIR must be lodged immediately in such cases and which is not being followed by the aforesaid Police Officers in discharging their respective duties. It also needs a mention that the mere forwarding of my complaint to the Commissioner of Police or any other senior Police Personnel does not amount to the action taken)
