- 4) Provide me the details of financial loss incurred out of riots happened in Muzaffarnagar.
- 5) Is it true that there was an intelligence report from IB regarding the certainty of riots in Muzaffarnagar.
- 6) Provide me the date from which the riots got commenced. Also provide me the date on which State Government of UP had approached the Government of India for providing paramilitary forces/army.
