

Dear and Respected Prime Minister,

This is regarding finalization of policy for grant of out of turn promotions to sportspersons of Central Armed Police Forces who have excelled in sports and brought laurel to the Nation at the level of Olympics, Commonwealth Games, Asian Games or the World Championships. We have been trying for over a year to get a policy approved.

2. Ministry of Home Affairs had sent a draft policy for grant of out of turn promotions to Sportspersons of Central Armed Police Forces to DoP&T for their approval on 6.5.2011. However, DoP&T decided to submit a common draft policy for out of turn promotions to sportspersons for all Government departments to COS and to the Cabinet for approval.

3. As the first four recommendations of Committee of Secretaries are in accordance with the policy framed by Ministry of Home Affairs, DoP&T was requested on 6.3.2012 to allow MHA to implement these four recommendations pending the approval of the policy by the Cabinet. Approval of DoP&T has not been conveyed. I am reminding MOS(PP) once again.

4. The approval of the Cabinet to the proposed policy to be issued by DoP&T is still awaited. In the absence of the policy, MHA is unable to give "out of turn promotions" to the sportspersons of Central Armed Police Forces for their medal winning performance in Commonwealth & Asian Games even 18 months after the Commonwealth Games. I shall be grateful if you could kindly look into the matter and direct that the Cabinet note of DoP&T on the subject be taken up for the consideration and for approval of the Cabinet.
