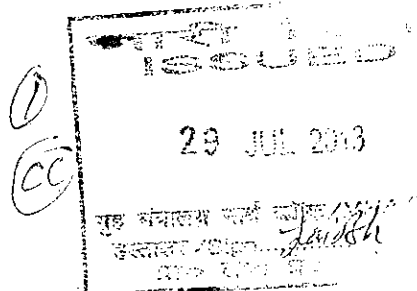
Sir,

In respect of points No. (i) and (iv) of your application, it may be stated that an amount of Rs.68.687 crore (Rupees Sixty Eight crore Sixty Eight lakh Seventy thousand only) has been reimbursed to the State Government of J&K for expenditure on Return & Rehabilitation of Kashmiri Migrants upto todote.The SRE is a Non-Plan reimbursement Scheme which covers the following schemes:-

- i) Housing
- ii) Transit Accommodation
- iii) Continuation of Cash Relief to Migrants
- iv) Students Scholarship
- v) Employment
- vi) Assistance to Agriculturists/Horticulturists
- vii) Waiver off interest on loans.


