

Please refer to endorsement of letter No.A-43020/01/2013-RTI dated 19.12.2013 with reference to your RTI application dated 7.12.2013 for providing information pertaining to financial assistance to Jammu & Kashmir for stop terrorism.

2. Insofar as K-II Desk under J&K Division is concerned, for point No. 6 to 8 of your application, it is stated that with a view to augment the resources of the J&K Government to fight the terrorism and contain militancy besides maintaining law and order in the State, a separate SRE scheme for J&K was introduced. Under the scheme Security Related Expenditure (Police) Rs. 4445.66 crore and under SRE (Relief & Reh.) Rs. 2274.25 crores have been reimbursed to the State Govt. of J&K upto 31.12.2013. The year-wise amount reimbursed under Security Related Expenditure is enclosed.

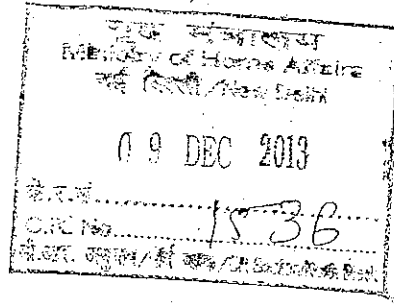
