



These officers claim that the shutting down of the TSD by the present Chief of Army Staff, is a "major reason why there has been a spurt in cross-border intrusions over the past year. It is understood that with the use of the technical means of the TSD "the Army was able to penetrate enemy territory and reach the actual source of terror operations and not just tackle the symptoms". It also implies that the infiltration was the least during the period 2010-2012 and have increased manifold ever since the TSD was disbanded.




