

1	<p>To know about Ex-CAPF equivalent to Ex-Servicemen for reservation.</p> <p>With due respect I want to know about the quota status of Central Armed Forces which has been approved as the Ex-CAPF which is equivalent to Ex-Servicemen but till now no state and Govt of India has given this type of reservation to these Para Military Personnel, which has been announced by our Home Minister in 2012.</p> <p>Sir, actually I want to know weather the reservation is given to them or not and if yes then why not been intimated as they are doing equivalent job to the military.</p>	<p>As per MHA OM No. 27011/100/2012-R&amp;W dated 23/11/2012, retired Central Armed Police Forces personnel from CRPF, BSF, CISF, ITBP and SSB have been declared as "<u>Ex-CAPF personnel</u>" and not "<u>Ex-Servicemen</u>". Based on such designation, the State/UT Governments are at liberty to extend suitable benefits to Ex-CAPF personnel at par with Ex-Servicemen.</p> <p>Since, CAPF personnel retire only on attaining the age of 57/60 years, no further employment at par with ex-servicemen is required for Ex-CAPF personnel.</p> <p>However, based on this Ministry Office Memorandum No. 27011/100/2012-R&amp;W dated 23/11/2012, State/UT Governments may consider to provide job to the widows/Next of Kins (NOKs) of deceased CAPF personnel who sacrificed their lives for the Nation and extend other suitable benefits to Ex-CAPF personnel at par with Defence Force personnel.</p>

3. In case you are not satisfied with the reply, the appeal in the case lies with Dr. Nirmaljeet Singh Kalsi, Joint Secretary (P-II), Room No. 171-B, MHA, North Block, New Delhi-01. The appeal may be filed within 30 days from the date of receipt of this reply.
