That the appellant has submitted an on line RTI application under RTI Act 2005 to the

Sh.G.V.V.Sharma,JS (DM),Ministry of Home Affairs, C wing, 3rd floor,Jai Singh Road, New  
Delhi-110001 is the appellate authority (Attached the copy of online RTI and Forwarding

My GROUNDS for the appeal are as follows:

- 01. That I Arun Kumar P.N who is serving as Inspector presently in 04th battalion National Disaster response Force ,suraksha campus ,Arakkonam under the administrative control of Mr.M.K.Verma who is now the commandant of this battalion.
- 02. In accordance to Rule-56(1 )- A of FRSR for Voluntary Retirement, I had tendered three months prior notice for relieving me from service vide notice dated 30.08.2013 in which I had requested to relieve me on VRS wef 30.11.2013 due to personal compulsions. I had also submitted the same application to DIG CISF South Zone HQrs., Chennai directly who is my appointing authority.


03. I had received a certificate vide Commandant 4 BN NDRF Arakkonam issued vide letter No.E-28018/4 BN NDRF (A)/Doc/QS/13-9049 dated 18.11.2013 in which it has been stated that I had the net qualifying service of 20 years 02 months and 12 days as on 30.10.2013. For tendering VRS notice the government employee is required for 20 years of net qualifying service which I had completed as per the above certificate.

04. After That Commandant Mr.M.K.Verma under Colourable administration did not forwarded my application to the competent authority till date and thus he is harassing me through out the entire period. Eventhough I represented the matter on various occasions, there is virtual collapse on the redressel mechanism of the organization with people having Jurassic mindset.

05. vide C.C.S pension rule 48-A-2, "Notice of voluntary retirement given under sub rule(1) shall require acceptance by the competent authority: provided that where the appointing authority does not refuse to grant the permission for retirement before the expiry of the period specified in the notice, the retirement shall become effective from the date of expiry of the said period"

I am eligible for voluntary retirement from service as per the govt.rules .The officials willingly violate the provisions of govt. rules in order to harass me maximum and this is a gross human right violation. Our Constitution establishes a democratic republic. Democracy requires an informed citizenry and transparency of information which is vital to its functioning. The purpose and object of the RTI act is not only to provide information but to keep a check on corruption, and dismal record of misgovernance which colludes to deny Citizens their essential rights and dignity. The above act itself is a gross violation of human right laws and gross dereliction of duties from responsible officials. Therefore the information sought by me is supplied immediately.
