Sir,

I am directed to refer to your application dated 14-03-2014 received in this Division on 25-04-2014 through RTI Section vide their RTIMIS No.MHOME/R/2014/60672/4 dated 24/04/2014 and to furnish the following information under the Right to Information Act, 2005:-

*“There are 126 employees working as Multi Tasking Staff (MTS) in the Ministry of Home Affairs who have been appointed on regular basis during the period from 2006 to 2012. They were working as Casual Labourers (Temporary Status) in MHA from the year 1993. Their services were regularized under the Casual Labourers (Grant of Temporary Status and Regularisation) Scheme of Government of India, 1993. These employees continue to contribute towards GPF as per the directions of the Hon’ble CAT, Principal Bench, New Delhi and are covered under the CCS (Pension) Rules, 1972. However, the matter is pending in the Hon’ble Supreme Court of India.”*

2. For information relating to CRPF and ITBP, your application is being transferred to concerned Authority under Rule 6 (3) of the RTI Act, 2005.

3. The appellate authority in respect of this matter under the RTI Act is Shri Satpal Chouhan, Joint Secretary (Admn. & CVO), Ministry of Home Affairs, Room No.194, North Block, New Delhi-110001, (Tel.No.23093178), and the appeal, if any, can be made within 30 days of the issue of this reply.
