
2. Whereas RTI application was returned to applicant online on 11/03/2014 by the CPIO as the subject matter meant for the Public Authority under the State Government.

4. Whereas Shri Hasan Ali is informed that under the Right to Information Act, 2005, an applicant can seek that information from Public Authority which exists in the records and is held by/under the control of that public authority. Therefore, the reply given by the CPIO is in order.

5. However, a copy of the RTI application and appeal of Shri Hasan Ali is being forwarded to the Joint Secretary(Judicial), Ministry of Home Affairs for providing information to the applicant if available with him.

6. The Appeal of the appellant is accordingly disposed of.


