Sub: First Appeal preferred by Shri Paras Nath Singh under RTI Act,2005-regarding.

Whereas Shri Paras Nath Singh vide his RTI application dated 06/01/2014 (received in this Ministry on 10/02/2014 through President's Secretariat), had sought information about action taken on his communication dated 23/12/2013 which was forwarded by the President's Secretariat to the Home Secretary vide their letter No. F.47(2)-CA(1)/2013 dated 31/12/2013.

- 2. Whereas the RTI application of Shri Paras Nath Singh was forwarded to Joint Secretary(Judl.) on 14/03/2014 after receiving the confirmation of the movement of the said communication of the President Secretariat dated 31/12/2013 from the office of the Home Secretary and from the office of Secretary(BM).
- 3. Whereas vide his first appeal dated 31/03/2014, Shri Paras Nath Singh has stated that his application was forwarded to the CPIO i.e. Joint Secretary(Judl.) much after the 30 days which was further forwarded by Joint Secretary(Judl.) to the CPIO in HR Division. He has further stated that various CPIOs are tossing his application from one section to another and he has not been provided any information.
- 4. Whereas the appeal of Shri Paras Nath Singh was forwarded to Appellate Authority concerned i.e. Joint Secretary(Coord.) and Joint Secretary(HR) by the Nodal RTI cell on 06/05/2014.

- 5. Whereas Shri Paras Nath Singh is informed that the RTI Section had received his RTI application on 12/02/2014. Since, the movement of the said communication of President Secretariat dated 31/12/2013 was not available with the RTI Section, therefore the movement of the said communication was confirmed from the office of the Home Secretary and from the office of Secretary(BM). On receipt of the confirmation from the office of Secretary(BM) on 13/03/2014, his RTI application was sent to the Joint Secretary(Judl.) on the very next day i.e. on 14/03/2014. Therefore there was no delay on the part of nodal RTI Section. It has further been informed by the Joint Secretary(Judl.) vide his O.M. dated 15/05/2014(copy has also been sent to the applicant) that reply to RTI application has already been sent by the HR Division to the applicant on 25/04/2014. However, a copy of appeal is also being sent to Joint Secretary(HR) for taking necessary action.
- 6. In view of the above, the appeal of the appellant is accordingly disposed of.

This first appeal is filed under section 19(1) of the RTI Act, 2005 against not furnishing the information by the CPIO even after the mandatory 30 days provided under Dear Sir. section 7(1) of the RTI Act, 2005 with respect to my RTI application of even no. dated 06.01.2014 which was transferred to the CPIO, MHA by the President Secretariat vide their

- In this regard, it is submitted that the said RTI application was received in MHA on letter No. dated 06.02.2014. 10.02.2014 from the President Secretariat. And the same was forwarded to the JS (Judicial) only on 14.03.2014 i.e. much after the 30 days by Mr. S. Samanta, Under Secretary to the Govt. of India vide his letter No. A-43020/01/2014-RTI dated 14.03.2014.
 - Further, the IS (Judicial) & CPIO in turn forwarded the RTI application to the CPIO (HR) division of the MHA on 21.03.2014 with a copy of same to the RTI Section, MHA. Nevertheless, I have not been provided with any information even after more than one month. Various CPIOs of the MHA are tossing my RTI from one section to another but they are not concern with providing the information to the undersigned. Moreover, it is provided in section 5(4), 5(5) & 6(3) of the RTI application that any RTI application must be forwarded or transferred, whatever the case may be, within 5 days from the receipt of the RTI application. However, in the instant case, aforesaid CPIO of RTI Section, MHA forwarded the same to JS (Judicial) after the 30 days. However, the information has not been provided.
 - 5) It is really a matter of great disappointment that officers in MHA are not taking RTI Act seriously and acting in a very casual behaviour. They are disregarding the letter and spirit of
 - 6) Accordingly, it is requested that this appeal may be dispose of with collect the information the RTI Act, 2005. from the information holder and providing the same to the appellant without any further delay. I also request that necessary instruction be issued to all CPIOs to adhere with the time limit as prescribed under the RTI Act, 2005
