Please refer to this Ministry's letter No. 11045/10/2014-VTV dated 8th May, 2014 in connection with your application dated 16.4.2014 seeking information regarding scheme of the Government of India for the victims of terrorist attacks under the RTI Act, 2005.

2. In this regard, as far as the undersigned is concerned, it is informed that the 'Police and 'Public Order' are State subjects and action with respect to maintenance of law and order primarily lies in the domain of the State Governments concerned, who deal with the various issues related to the Left Wing Extremist (LWE) activities in the States. The Central Government monitors the situation closely and supplements and coordinates their efforts in several ways, inter alia, including reimbursement of expenditure incurred by the State Governments on Anti-naxal operations under the Security Related Expenditure (SRE) Scheme. This includes the ex-gratia payment to the family of victims of the naxal violence incurred by the respective State Governments. The year-wise details of funds released to the nine Left Wing Extremism (LWE) affected States viz. Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Uttar Pradesh and West Bengal under the SRE Scheme since its inception i.e w.e.f. 01.04.1996 to 31.03.2014 is given in the table below:

Please refer to a copy of this Ministry's letter No. A-43020/01/2014-RTI, dated 02.05.2014, forwarded to IS-II Division, Ministry of Home Affairs by Shri S. Samanta, Under Secretary (RTI) of this Ministry, alongwith a copy of your RTI application dated 16.04.2014, seeking information regarding the scheme of Govt. of India for the victims of terrorist attack, under the Right to Information Act, 2005.

2. In this regard, it is stated that the Central Government (IS-II Division) is administering a scheme titled "Central Assistant to the Civilian Victims of Terrorist/Communal/Naxal Violence." for the sustenance and maintenance of the families of the Civilian victims of Terrorist/Communal/Naxal violence. The said scheme is effective from 01.04.2008 in respect of terrorist and communal violence and from 22.06.2009 in respect of cases of naxal violence. Under the scheme, an amount of Rs.3 lakhs is given to the civilian victims / Next of Kin (NOK) of the victim in the case of death or incapacitation/disability with 50% or more, subject to the condition that no employment has been provided to any of the family members of the victims by the State Government.

3. As per the revised guidelines on the "Central Scheme for Assistance to Civilian Victims of Terrorist/Communal/Naxal Violence" issued by this Ministry vide letter dated 29.06.2012, the payment of assistance to the victims / Next of Kin of victims of terrorist violence shall be paid by the District Magistrate/Deputy Commissioner and thereafter, the State Government shall submit the proposal to the Ministry Home Affairs for reimbursement.

4. The copy of your RTI application in also being forwarded to Naxal Management Division and North East Division of this Ministry.
