**Point No. 2 & 4**

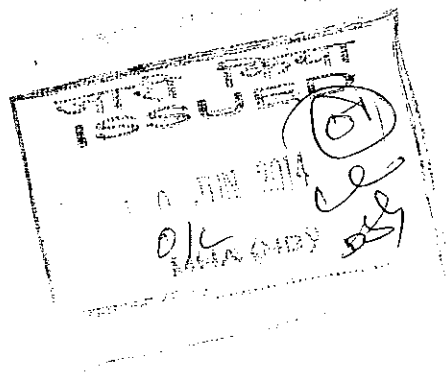
In view of the serious militancy/insurgency in J&K, the Govt. of J&K have to incur more expenditure for maintaining peace and tranquility. It has led to an additional burden on its budget. In order to mitigate this problem and with a view to augment the resources of the J&K Government to fight the terrorism and contain militancy besides maintaining law and order in the State, a separate SRE scheme for J&K was introduced. It provides for reimbursement of expenditure on Police (SRE - Police) which mainly support the logistical requirements of police force of J&K and Relief & Rehabilitation (SRE-R&R), which support the expenditure on relief and rehabilitation of the Kashmiri migrants who have been uprooted from the valley during militancy period. The details of fund released under SRE scheme during the period 2009-14 is as below:



Please refer to your RTI application dated 04.05.2014 (received on 19<sup>th</sup> May, 2014) for furnishing information sought in your RTI Application.

2. The information regarding Point No.2, to 4 is that Police Modernization Division deals with the Scheme for the Modernization of State Police Forces. Under the Scheme for the Modernization of State Police Force, the funds are allocated to State Governments. A list of funds released to the State Governments for the financial year from 2008-09 to 2013-14 is enclosed.
3. "Police" is a State subject as per Entry 2 of the List-II of VIth Schedule to the constitution of India. As such, it is primary responsibility of the State Governments to modernize their Police forces by equipping the State Police Forces adequately. The objective of the MPF Scheme is to strengthen the State Governments to control internal security and law and order situations by equipping the State Police Forces adequately and strengthening their training infrastructure. The focus of the scheme is to strengthen the police infrastructure at the cutting edge level by construction of secure police stations, training centers, police housing (residential), equipping the police stations with the required mobility, modern weaponry, communication equipment, forensic set-up etc.
4. The remaining information sought by you does not pertain to PM Division. The RTI application dated 04.05.2014 is therefore, transferred to all CPIOs of MHA under Section 6(3) of RTI Act-2005.
