**FR II** is a RTI application dated 02.05.2014 of Shri R. K. Jain received through RTI Cell, MHA's OM No. A-43020/01/2014-RTI dated 21.05.2014.

In so far as this Section is concerned, the following point wise information may be provided to him:-

(A & B): The relevant information may be provided by RTI Cell, MHA as the CPIO/Nodal PIO/PIO/ First Appellate Authority are nominated by them.

(D): Necessary action in this regard is being initiated separately. However, as desired, copies of RTI replies and appellate Order passed from January 2014 to till date may be given.


(E to H): Nil
