2. In this regard, it is stated that Mrs. Priyanka Gandhi is an SPG protectee. Accordingly, a copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to CPIO, SPG for providing requisite information regarding security provided to Smt. Priyanka Gandhi Vadra directly to you.

3. Shri Robert Vadra is not a SPG protectee. In this regard, it is stated that security to an individual is provided on the basis of assessment of threat carried out by the security agencies. Further details in this regard are exempted under Section 24(1), 8(1)(g) and 8(1)(j) of the RTI Act-2005 and cannot be disclosed. Regarding expenditure incurred on security, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
