Subject: For renaming 'Pakistan occupied Kashmir' or 'Pakistan occupied Jammu & Kashmir' and replacing by the name of **"Pakistan Occupied Area of Bharat (POAB)"** as per the provisions of Article 1(2) and 1(3) and First Schedule of the Constitution of Bharat.

Sir,

It has been come out from the media that the Government lead by your goodself has taken a decision to change the name of the area called as 'Pakistan occupied Kashmir' and in its place, the name 'Pakistan occupied Jammu & Kashmir' will be substituted.

If it is so, it is a welcoming decision because by using 'Kashmir', a wrong message is being gone that Kashmir has some separate existence from 'Jammu & Kashmir'. But it is still thought that the decision of changing the name of 'Pakistan occupied Kashmir' and replacing it by 'Pakistan occupied Jammu & Kashmir' is a half hearted decision.

Under **Article 1(2) and 1(3) of the Constitution of Bharat**, it is provided that the territory of India shall comprise the territories of States and the Union territories, which is specified in the First Schedule and under **Clause 15 of First Schedule**; the State of Jammu & Kashmir is specifically mentioned.

Thus looking into the aforesaid provision, it is unconstitutional to continue either the name 'Pakistan occupied Kashmir' or 'Pakistan occupied Jammu & Kashmir'. Such a name too give a message at the national level as well as at the International Scenario that the area socalled as 'Pakistan occupied Kashmir' or 'Pakistan occupied Jammu & Kashmir' has some separate existence from the nation namely 'Bharat'.

There is a lot of hope from the Government lead by Bharatiya Janta Party, which believe and claim to believe in maintaining the unity and integrity of the nation.

It is hereby prayed to change the name of area socalled as 'Pakistan occupied Kashmir' or 'Pakistan occupied Jammu & Kashmir' and replace it by the name of "Pakistan Occupied Area of Bharat (POAB)" as per the provisions of Article 1(2) and 1(3) and First Schedule of the Constitution of Bharat.
