

This Ministry has received an application dated 26/02/2013 under the RTI Act, 2005 from Shri Manjeet Singh (received on 18/03/2013) wherein he has sought huge information on varied subjects.

- 2. The information sought in the application is not available in a centrally compiled form in this Ministry whereas it is scattered among various Public Authorities. Under the RTI Act, 2005, Public Authority is under obligation to provide only that information (to the applicant) which exists in the records and is available with or under the control of that Public Authority. Since transfer of application to all these authorities is not possible, it is being transferred under Section 6 (3) of the RTI Act, 2005 to only one public authority viz. Ministry of External Affairs for furnishing information in respect of Point No. 12.
- 3. As regards the information related to the Ministry of Home Affairs, the application is being forwarded to the designated CPIOs of this Ministry for taking necessary action. The information on remaining points may be obtained directly from the concerned Public Authority as specified by the Department of Personnel & Training in their O.M No.10/2/2008-IR dated 12.06.2008 (copy enclosed).
