

- 2. The information sought by the applicant in respect of points 1,2 & 4 is not maintained in the FFR Division, as such not available with the signing CPIO. The information in respect of point 3 has been provided to the appellant. The same was conveyed to the appellant on 18/01/2013. The appellant then approached the CIC on 10.04.2013 in a second appeal and CIC has directed Ministry of Home Affairs to provide the information to the appellant on the points mentioned in the RTI application within thirty days of the CIC's order dated 15.01.2014 (which was received by the CPIO on 27.01.2014). A copy of the CIC's order is enclosed herewith.
- 3. The points on which information required by the Appellant are given below:-
- (i) the number of casualties resulting from the partition of 1947, including the community-wise break-up;
- (ii) the number of displaced persons who crossed over from India to Pakistan and from Pakistan to india;
- (iii) whether any Commission of Enquiry was set up. If so, a detailed report of the Commission set up and its report; and
- (iv) If there is no enquiry report, the reasons for it.

ORDER

Facts:

1. The appellant filed an RTI application on 23-11-2012 seeking information about the casualties during the 1947 Partition.

2. The CPIO responded on 18-1-2013. Some information was provided while other information was denied on the ground that it was not maintained by the respondent organization. The appellant filed an appeal with the first appellate authority (FAA) on 29-1-2013. responded on 6-3-2013 and upheld the decision of the CPIO. appellant approached the Commission on 10-4-2013 in a second appeal.
