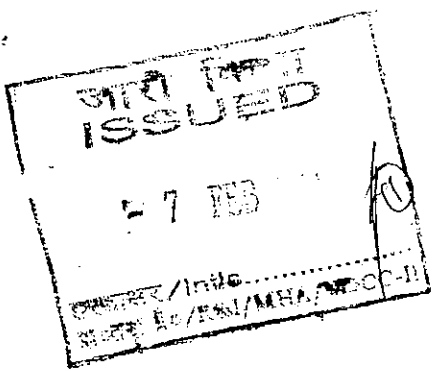

Sir,

Please refer to your online RTI application dated 14.01.2014 received in this unit on on transfer on 13.02.2014.

2. With reference to point Nos.(1) to (4) of your application, it is stated that the responsibility for providing security to individuals, including RTI Activists, rests primarily with the State Government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. The security is provided on the basis of threat assessment carried out by the security agencies. Security to an individual is not provided solely on the basis of his/her being a RTI Activist etc. However, information sought by you may be related to CS Division, MHA and DOP&T. A copy of your RTI application has already been forwarded to DOP&T vide RTI Cell, MHA's OM No.A-43020/01/2014 dated 10.02.2014. A copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to CS Division, MHA for providing requisite information directly to you.

3. With regard to point No.(5) of your application, it is stated that this unit has not issued letter dated 24.06.2013 referred to by you. However, a copy of your application is being forwarded to all CPIOs of MHA for providing requisite information directly to you, if any, available with them.

4. As regards point No.(6) of your application, it is stated that the subject matter may be related to Government of U.P. Accordingly, a copy of your application is also being forwarded to Government of U.P. You are requested to approach PIO of State Government of U.P. for the requisite information.

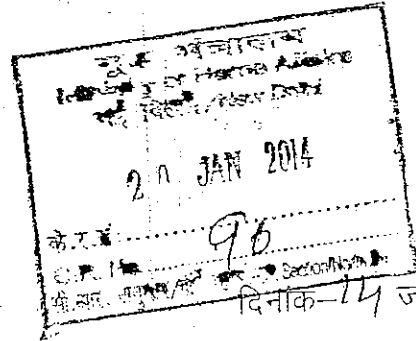
