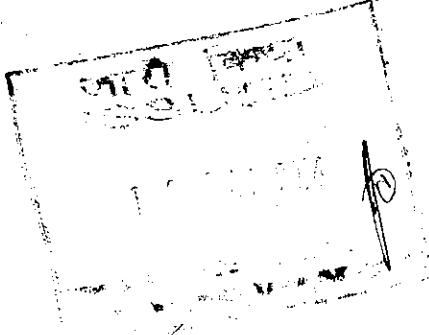



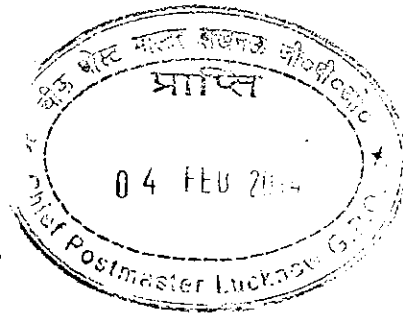

REQUEST TO GET INFORMATION UNDER RIGHT TO INFORMATION ACT 2005

Sir/Madam,

Please provide me detailed and complete information on under-mentioned aspects together with related correspondence/file-noting/documents etc related to filing of CRIMINAL F.I.R. by CBI in a case in which U.P. Cadre 1983 batch IAS officer Sadakant was one of the accused as he was allegedly paid by the private companies a huge sum of money in connection with a Rs 200 crore-contract pertaining to construction of a road at Leh in Jammu and Kashmir awarded to NPCC by the Ministry of Home Affairs, inquiries conducted by Government of India in the matter of accumulation of black money by Sadakant and his family.

- 1) A set of Certified copy of all record contained in service dossier of SADAKANT.
- 2) Information on punishment awarded to Sada Kant by Government of India for his alleged involvement in corruption, making confidential information public and anti-national activities.
- 3) Certified copies of documents including note-sheets of the file(s) in which the matter of Rs 200 crore-contract pertaining to construction of a road at Leh in Jammu and Kashmir awarded to NPCC by the Ministry of Home Affairs was processed and finalized.
- 4) Certified copies of those National information which were said to be sold by SADAKANT for earning black money for himself and for his family members.
- 5) Certified copy of search warrant as per which a search was conducted by CBI at Sada Kant's Chanakyapuri residence in Delhi and the report / outcome of the said search.
- 6) All documents related to the bribe paid by the private companies to Sada Kant in connection with a Rs 200 crore-contract pertaining to construction of the said road at Leh in Jammu and Kashmir awarded to NPCC by the Ministry of Home Affairs.
- 7) Certified Copies of evidences that CBI had gathered against Sada Kant during investigation and also Sada Kant's defence regarding evidences found against him.
- 8) Names and other available details of relatives of Sada Kant who enjoyed air travels and other facilities at the cost of contractor from a private firm.
- 9) Total loss estimates in Rupees to the Government of India due to Sada Kant's alleged involvement in corruption, making confidential information public and anti-national activities.
- 10) Certified copies of all studies conducted by Government of India in the instances of involvement of such heinous acts like involvement in corruption, making confidential information public and anti-national activities by SADAKANT and/or his family members.
- 11) Information on official estimates of total black money accumulated by said IAS Sadakant in his entire life and as held by him & his family.
- 12) Details of movable ( Cycles, ,Cash,Jewellery,diamonds,foreign currency,shares,debentures, gemstones etc.) in possession & immovable properties held in India and abroad in the names of Sadakant and his family members.
