It is observed that the point No. 1, 4, 6 and 7 are related to BM Division. The schemes being undertaken by sections under the jurisdiction of the undersigned are security related infrastructure works. The Government has sanctioned constructions of fencing to the extent of 3326.14 km along Indo-Bangladesh Border out of which 2823 km work has been completed. These works were targeted to be completed by March, 2014. However, same is spilled over.

2. In response to the point No. 4, 6 & 7 of your application, it is stated that several communications have been made with the State Government and concerned authorities. There are approximately 49 pages of such communication available in this Division. You are therefore requested to deposit Rs. 98/- (Rs. 3. Please provide the fact that the smugglers, brokers, and persons involved in smuggling of cattle to Bangladesh are taking part in the auction organised by B.S.F.
4. Copy of the orders passed by the Government of India to curb zero the illegal smuggling of cattle with Bangladesh Boarder.
5. Information regarding special surveillance equipments and other necessary arms and ammunitions provided to B.S.F. personnel to stop and curb the cattle smuggling.
6. Please provide the copy of the correspondance made with relevant State Governments to take necessary action for the prevention and stopping the illegal transportation of cattle being sent to Bangladesh Boarder for illegal smuggling.
7. Copy of the action taken and positive response received by the State Governments to stop the illegal transportation of cattle towards the Bangladesh Boarder.
8. Number of the F.I.R.s filed against the B.S.F. personnel during last 10 years for being involvement of illegal co-operation, malafide support and conspiracy in the transportation of cattle to Bangladesh.
9. Please provide the information that B.S.F. personnel which performing their duties are facing very difficulty in case of firing/attacks and attempt to murder by Army personnel of Bangladesh.
10. Please provide yearwise number and percentage of last 10 years of cattle which are smuggled to Bangladesh and cattle could not be detected and seized by the BSF personnel.
