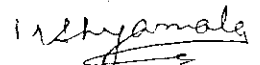

Regarding information sought in Point No. 1 & 2 of your application, it is informed that the use of the State Emblem of India is regulated by the State Emblem of India (Prohibition of Improper Use) Act, 2005 and the State Emblem of India (Regulation of Use) Rules, 2007 [as amended in 2010]. The aforesaid Act and Rules are available on this Ministry's website 'www.mha.nic.in'. As per Rule 10 (2) of the aforesaid Rules, "No Commission or Committee, Public Sector Undertaking, Bank, Municipal Council, Panchayat Raj Institution, Parishad, non-government organization, University, other than those authorized under these rules, shall use the emblem in any manner". The details of the Constitutional or Statutory Authorities, Ministries or Departments of the Central Government, State Governments or Union Territory Administrations and other Government Functionaries which may use the State Emblem of India for various purposes has been specified in the said Rules.

2. The aforesaid documents (Act and Rules) comprise 16 pages, for which ₹ 32/- (@ ₹ 2/- per page) may be remitted towards the photocopy charges of the documents under the RTI, 2005 by way of cash against proper receipt or Indian Postal Order/Bank Draft/Banker's Cheque payable to "Accounts Officer, Ministry of Home Affairs" to enable this Ministry to send the copies of the same to you.

3. Appeal may be made under Section 19 (1) of the Right to Information Act to the Appellate Authority within 30 days.
