Sir,

I am directed to forward herewith Seven representations (as per list enclosed in Annexure), in original, received from various aggrieved persons and complainants relating to various grievances and complaints on the above subject

2. Since 'Police and 'Public Order' are State subjects under the Seventh Schedule to the Constitution of India, it is the responsibility of the concerned State Government to prevent, detect, register and investigate crime and prosecute the criminals involved through the machinery of its law enforcement agencies, and hence, you may take action on the representation, as deemed appropriate.
3. So far as the request of some of the petitioners for CBI enquiry of their cases is concerned, it may please be kept in view that the Union Government cannot, suo-moto, entrust to the Central Bureau of Investigation (CBI), the investigation of an offence which has taken place in a State, unless the State Govt. proposes and gives its consent under Section 6 of the DSPE Act, 1946 for extension of jurisdiction of CBI in respect of that offence. Further, the Ministry of Home Affairs has no administrative jurisdiction over CBI, which comes under the control of the Ministry of Personnel, PG & Pensions, Department of Personnel & Training. The Ministry of Personnel, PG & Pensions, Department of Personnel & Training, may be approached if it is desired to hand over any case to CBI, for such requests of the petitioners /complainants.
