3. The points on which information required by the Appellant is given below:-

- (i) Copies of instructions/orders issued by the Competent Authorities under RTI Act.
- (ii) Number of RTI activists killed in India since the application/implementation of the RTI Act, 2005.
- (iii) Instruction/orders issued by the Govt. of India (MHA) for safety and security of RTI activists/persons.

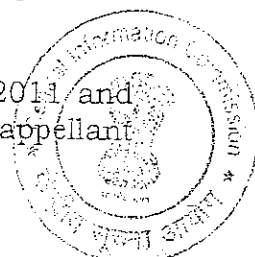
ORDER

Facts:

1. The appellant filed an RTI application on 29-11-2011 requesting for copies of instructions/orders issued by the competent authorities under the RTI Act, that pertained to the RTI activists and instructions/orders issued for their safety.
2. The CPIO responded on 16-12-2011, informing the appellant that the answering CPIO has no in-puts to furnish on the issues raised by the appellant. The appellant filed an appeal with the first appellate authority (FAA) on 4-4-2012. The FAA responded on 2-5-2012 and directed the Under Secretary(RTI), MHA and DOPT to furnish the information to the appellant. The appellant approached the Commission on 11-1-2013 in a second appeal.

Hearing:

3. I heard the appellant through video-conferencing. The respondent was present personally in the hearing.
4. The appellant referred to his RTI application of 29-11-2011 and stated that he had sought information on three points. The appellant

stated that he wanted a copy of the laws which the GOI had passed about RTI implementation along with the various rules. Secondly, he wanted to get the particulars of the persons who had been casualties as a result of the implementation of the RTI Act and thirdly the steps taken by the Central Government for the protection of those involved in the implementation of the RTI Act. The appellant stated that the response that he got from the CPIO on 16-12-2011 was casual as the MHA simply sent a response without any application of mind that they have no inputs to furnish.

5. The respondent stated that their section was not dealing with this subject so accordingly they have responded. The respondent stated that they were not clear about what to do with this RTI application. The respondent stated that they will procure the requisite information from the pertinent sections and provide it to the appellant.



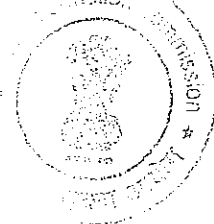
6. The respondent is directed to provide the information to the appellant on the points mentioned in the RTI application within 30 days of this order.
