Sir,

Please refer to your RTI application dated 12.05.2014 received in this unit on transfer on 02.06.2014.

2. In this regard, it is stated that subject matter does not relate to this unit. This unit deals with matter related to provision of personal security on the basis of threat assessment carried out by the security agencies. Traffic movement during the visits of VIPs is regulated by State Governments/UT Administrations concerned, in whose jurisdiction such VIPs happens to be. It is noted that a copy of your RTI application has already been forwarded to Delhi Police for providing information on various points raised by you.

3. However, traffic on roads during the movements of Hon'ble Prime Minister/President/Vice President are followed as per special guidelines related to security arrangements for them. The nature of the road, volume of traffic are taken into consideration in regulating the traffic. As per the guidelines, care has been taken to ensure that inconvenience to the public is kept to the barest minimum. It has been prescribed that where cross traffic has to be stopped, it should not be for more than a couple of minutes. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005 and cannot be disclosed.

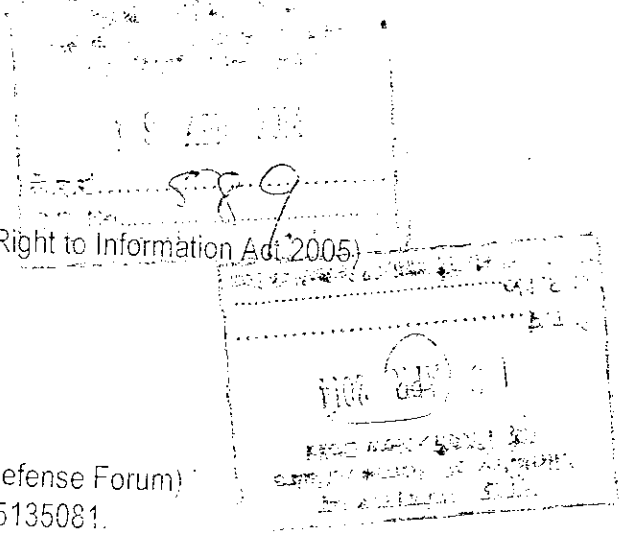

- 3) Kindly mention under rules what legal action is taken against a person who refuses to stop or tries to pass through the road which is closed for traffic for the easy and free movement of the VIPs on the road. Kindly provide the relevant sections under law in this regard.
- 4) Kindly provide the clear and certified copy of the order/directive etc. which allows ambulances/patients etc. to pass through the road which is closed for traffic for general public for ensuring easy and free movement of VIPs etc on the roads.
- 5) Kindly provide the clear and certified copy of the order/directive etc. which allows ambulances/patients etc. to pass through the road which is closed for traffic for general public for ensuring easy and free movement of VIPs etc on the roads.
- 6) Please provide the certified copy of file notings on the movement of this RTI application.
