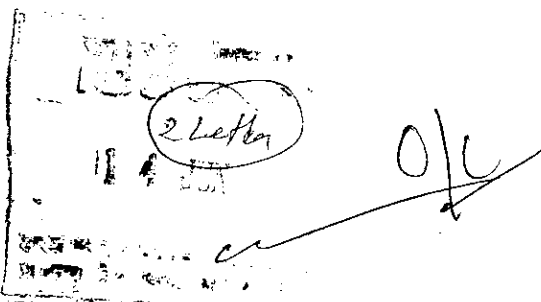



My client knew about the said facts when the S.P. of Police, Chittoor issued a Memorandum in C.No.GI/1079/27/RTI ACT/2013 dt. 20.03.2013 pursuant to a request made under the RTI Act. That my client presumes that the Addl. Director General of Police, CID, A.P., Hyderabad also forwarded the same to the Ministry of Home Affairs, New Delhi for deletion of his name from the list of LOC. In view of the same, my client requests you to furnish the following information under Sec. 6 of the Act:-

4]. What is the procedure being followed by the department for deletion of the names from the list of Look Out Circular.

5]. The basis/complaints for opening the LOC and copies of the cases, if any, mentioned therein.

In this connection, I wish to draw your attention to the 1st proviso to Section 24 of the RTI Act which specifically excludes application of sub Section (1) of Sec 24. Undoubtedly, the right to liberty and movement of my client from place to place is prevented in view of the illegal opening and operation of LOC without his involvement in any criminal case or requirement before any court, leave alone Criminal court. This action clearly violates his human rights thereby infringing the cherished constitutional creed enshrined in Art 21 of the Constitution of India.

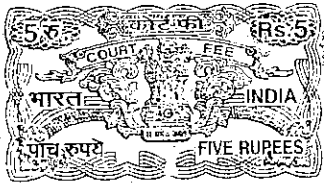



My client knew about the said facts when the S.P. of Police, Chittoor issued a Memorandum in C.No.GI/1079/27/RTI ACT/2013 dt. 20.03.2013 pursuant to a request made under the RTI Act. That my client presumes that the Addl. Director General of Police, CID, A.P., Hyderabad also forwarded the same to the Ministry of Home Affairs, New Delhi for deletion of his name from the list of LOC. In view of the same, my client requests you to furnish the following information under Sec. 6 of the Act:-

1]. What action is taken pursuant to the letter addressed by the originator requesting for deletion of the name of my client Sri K.L.N. Prasad S/o Perumal Mudaliar from the list of Look Out Circular.

2]. If the name of Sri K.L.N. Prasad, S/o Perumal Mudaliar is deleted from the list of LOC, kindly furnish a copy of the proceedings deleting his name.

3]. If his name is not deleted from the list of LOC, kindly furnish the reasons as to why the same is not done.

4]. What is the procedure being followed by the department for deletion of the names from the list of Look Out Circular.

5]. The basis/complaints for opening the LOC and copies of the cases, if any, mentioned therein.

In this connection, I wish to draw your attention to the 1st proviso to Section 24 of the RTI Act which specifically excludes application of sub Section (1) of Sec 24. Undoubtedly, the right to liberty and movement of my client from place to place is prevented in view of the illegal opening and operation of LOC without his involvement in any criminal case or requirement before any court, leave alone Criminal court. This action clearly violates his human rights thereby infringing the cherished constitutional creed enshrined in Art 21 of the Constitution of India.

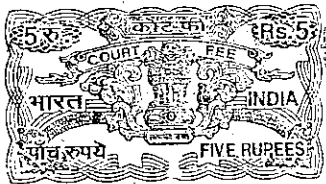
