Sub:- Application of Shri Ranjeet S Mudholkar under the Right to Information Act, 2005.

An RTI application dated 04.08.2014 (P-1-2/c) in respect of Mr. Ranjeet S Mudholkar received by Director(F-II) & CPIO MHA through Shri S Samanta, Under Secretary, MHA RTI Cell on 20.08.2014 (P-4/c) and further transferred to this Section vide Director (F-II) and CPIO, MHA OM No.3890/Dir(F-II)/14 dated 26.08.2014 which is received in this Section on 28.08.2014 may kindly be perused at P-5/c.

2. The information sought is as under :-

- i) Are Indian Nationals transiting through Nepal by air to other countries like China, Hongkong, Thailand etc. required to take approval from the Indian Government and/or Indian Embassy in Nepal before passing through the Immigration in Nepal to travel that country.
- ii) Kindly give details of all copies of communication exchanged between the Indian authorities and the Nepal government regarding the above.
- iii) If a person enters Nepal by air from India, then decides to travel to some other country like China, Hong Kong, Thailand etc., and seek visa from the respective embassy of that country in Nepal, is he required to take approval from the Indian Government and/or Indian Embassy in Nepal before passing through the Immigration in Nepal to travel to that country and/or has to intimate the Indian Immigration at the time of leaving the country.
- iv) If a person enters any other country by air from India, say China, then decides to travel to some other country like DPRK, Korea, Hongkong, Thailand etc., where India has diplomatic relations and seeks visa from the respective embassy of that country in China, is he required to take approval from the Indian Government and/or Indian Embassy in China

Indian Embassy in China (in this case) before passing through the Immigration in China (in this case) to travel to that country and/or has to intimate the Indian Immigration at the time of leaving the country.

- v) Which are the countries, with whom India currently does not have diplomatic relations. Is an Indian Citizen permitted to travel to any country, with whom India does not currently have any diplomatic solutions.

It is worth to mention here that information asked by Mr. Ranjeet S Mudholkar is not pertaining to this Division as information asked vide para 2(i) and (ii) is pertaining to BoI and para 2(iii) to (v) is pertaining to MEA(CPV) Division.

3. If approved, we may transferred the RTI application to BoI & MEA for necessary action. A letter prepared is placed opposite in the file for approval please.
