My husband shri Shivayya Irayya Hiremath
was drawing central freedom fighter pension from Gazetted
Sub Treasury, Shirahatti, Tq. Shirahatti, Dist. Dharwad
under PPO No. 6936/FFC.

On account of old age he died on 13-4-1994 at
Havanur. I am being legally wedded wife of late
shri Shivayya I. Hiremath and applied for sanction of
central freedom fighter to me. With all efforts I
searched the records of my late husband's papers and
also PPO No. ⁶⁹³⁶~~9636~~/FFC.

After protracted correspondence with Sub-
Treasury Officer, Shirahatti and District Treasury officer,
Dharwad. Both the ppo's were sent to the Accountant General,
Bangalore for revalidation of pension. Since the claim
was more than one year old. Since the Accountant General,
Bangalore is not authorised to revalidate the pension
payment order pertaining central government freedom
fighter.

Lastly the both the PPOs i.e. Treasury portion
and pensioner's half were collected by the District Try.
officer, Dharwad with full particulars. The District

Treasury officer, Dharwad under his letter No.Try/PEN/FFE/C/96-97 dtd. 14-10-1996 has submitted the both PPOs bearing No.6936/FFC along with death certificate and letter add to Accountant General, B'lore for revalidation and to sanction family pension to me.

Sir since 1996 I requested several times to Sub-Treasury Officer, Shirahatti and also Dist.Treasury Officer Dharwad to take necessary action in the matter. The only reply was received by me is all the papers were pending in your office and as such the case was not settled till today. I am very eagerly waiting for reply from Dist. Treasury officer, Dharwad and Sub-Treasury Office, Shirahatti. No proper reply is received from District Treasury Officer, Dharwad and Sub Treasury Office, Shirahatti.

Sir, I lastly approach youykindself to look into the matter personally and to verify the records whether papers were sent to District Treasury Office,Dharwad or Sub-Treasury officer, Shirahatti.

Sir, I am financially hard hit in these hard days and more over no other sources of income to me to pull on my life. Hence the request.

Sir I will be highly obliged if you could take necessary action and consider the case on humanitarian grounds and sanction family pension to me at least before My life's time.

I am directed to refer to your RTI application dated 28.05.2013 received through Pay and Accounts Office, (Pension & Misc.), Ministry of Home Affairs regarding transfer of Central Pension in your name. Records of this Ministry has been checked but the above mentioned representation has not been received in this Ministry. However, I am to inform you that this Ministry has vide letter No.8/17/89-FF(P), dated 1-5-92 (copy enclosed) simplified the procedure for obtaining the pension by the legal heirs (spouse and unmarried unemployed dependent daughters) of the deceased freedom fighters who were in receipt of the Swatantrata Sanik Samman Pension. Therefore, pension disbursing officer is authorized to transfer the family pension after completion of the formalities.
