



The letter under reference was examined and it was found that the petitioner had not submitted any fresh set of acceptable documentary based evidence from the official record in support of his claim, hence it was not possible to decide it further. The decision was communicated the PS to Hon'ble Member of Parliament. A copy of the same was also endorsed to Under Secretary Government of Maharashtra vide letter dated 22 nd February, 2001.
