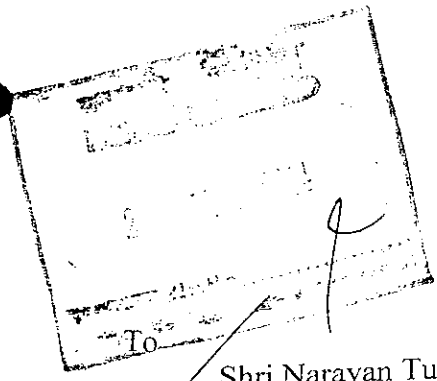


2. It is also inform you that in the context of the Right to information Act, 2005. information has been clarified as under on the website of DOPT:
