2. Information sought by you in point nos. 3, 4 and 6 of your RTI application, as available in the Foreigners Division, Ministry of Home Affairs is given below :-

Point nos 3 & 4 :- As entry of Bangladeshi nationals without travel documents into the country is clandestine and surreptitious, it is not possible to have a correct estimate of the total number of such illegal Bangladeshi immigrants living in different States in the country. A number of Bangladeshi nationals who have come on valid travel documents were also found to be overstaying. Details of arrival, overstayaal and deportation of Bangladeshi nationals from 2002 to 2011 are given below :-

Commission on 1st January and 1st July every year in pursuance of a Consular Access Agreement signed between India and Pakistan. As per the lists exchanged on 1.1.2013, 260 Pakistani prisoners and 37 Pakistani fishermen were lodged in Indian jails as in December 2012. Out of these, 10 Pakistani prisoners and 14 Pakistani fishermen have since been repatriated to Pakistan from January to April 2013. The lists of Pakistani prisoners and Pakistani fishermen exchanged with Pakistan High Commission on 1.1.2013 can be provided to you on payment of Rs 102 (51 pages x Rs. 2) by way of Indian Postal Order/Demand Draft in favour of Pay & Accounts office, Ministry of Home Affairs or by cash.

3. If you are not satisfied with the information furnished, you may file an appeal to Shri V.Vumlungmang, Joint Secretary (Foreigners) & Appellate Authority, Ministry of Home Affairs, Foreigners Division, NDCC-II Building, Jai Singh Road, New Delhi within the prescribed time limit.



This is in reference to your letter dated 03rd May 2013 no. 8/Imm/2013(139)-1429 sent by Sh. N.S. Bundela Deputy Director & CPIO in reply to my RTI. In which he has cited the reason for not providing the information by quoting Section 24 (1) and Second Schedule of RTI Act 2005 that exempts Security Agencies. Sir, now I would like to put across few points in regards to the same matter.

1. That the RTI Act 2005 exempts security agencies but with a rider that states that "Provided that the allegations of corruption and human rights violation shall not be excluded under the sub section. (Copy attached). Sir, the information I seek is for the purpose of getting to the bottom where I feel there could be a human rights violation and also of corruption which is why I require the details.
2. Because the information sought is absolutely beyond the purview of section – 8 of the Act no. 24 of 2005 and Official Secrets Act, to which you are quoting.
3. Because on the basis of presumption of fear of security cannot be made basis to refuse relevant information.
4. Because the press and news media are also revealing the facts

5. Because the desired information does not in any way impede the process of Justice.
6. Because no document can be classified arbitrarily as Secret or Confidential except as provided in the Act.
7. In regards to the information to State Government the application could have been forwarded to concerned CPIO or SPIO for the information.

Sir that is why I would ask you to please again look upon the request I had made through my RTI and provide me the relevant information otherwise there would be no scope other than that of going to CIC or to take remedial action as per the Law of the Land.


