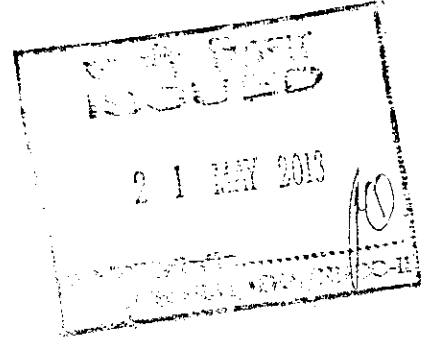


Sir,



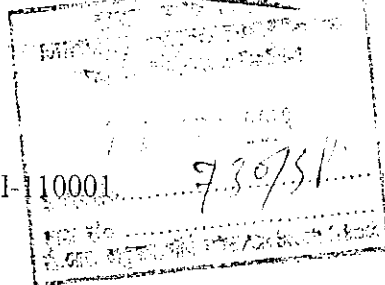
