1.	Whether the practice of issuing security clearance to foreign crew is out of a statutory requirement or compliance of Guidelines issued by DADF?	The Guidelines stipulate that operator will take clearance from the Government for assignment of foreign crew on board the vessel and payment to them. The information regarding statutory requirement of security clearance related to foreigners may be available with MHA.
2.	Are statutes silent about foreign national engaged on DSFVs operating in the EEZ outside territorial waters? What is the reason / justification for DADF to prescribe a new requirement (security clearance) related to foreigners?	It would not be appropriate to furnish the clarifications or reason / justification under RTI Act, 2005.
3.	Why does DADF go beyond its scope and prescribe a guideline to LOP vessel operators to register their vessels with MPEDA?	Information is not available with this Department.
4.	What will be the approximate number of Indian/indigenous DSFVs operating in the Indian EEZ without an LOP?	Guidelines/LOPs are issued as executive orders. Government may issue executive orders in absence of a statute. A list of valid LOPs is enclosed.
5.	Is LOP legally valid and justified? As of today, what is the number of DSFVs regulated by DADF?



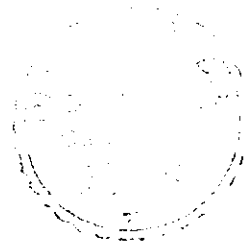

Dear Ms. Chowdhary,

Please refer to your D.O. letter No. 21005/1/2001-Fy(Ind) dated 29th January 2001 regarding procedure for grant of security clearance, followed by MHA, to foreign national working as crew on fishing vessels.

2. Security clearance given by this Ministry does not confer any right to the foreign national for employment as crew on fishing vessel. It is only clearance of crew from Suspect Index being maintained by MHA. If such clearances are being misused, in future, we have no objection for issuing security clearance only when the request is forwarded to us through the concerned nodal Ministry.

3. As regards the authority to issue security clearance is concerned the decision is conveyed normally at the level of Section Officer Under Secretary after competent authority approves it.

Sir,

Please refer to your application dated 23.04.2013 received by the undersigned on 23.05.2013 on transfer from Sh. G. Mohana Pai, Assistant Commissioner (Fisheries) & CPIO, Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their letter no.21006/217/2013-Fy [Ind] dated 20.05.2013 seeking information under the RTI Act, 2005.

2. With regard to information sought by you in point nos. 1 and 2 of your RTI application, it may be stated that in terms of provision contained in Section 3 (1) of Foreigners Act, 1946, the Central Government may by order make provision, either generally or with respect to all foreigners or with respect to any particular foreigner or any prescribed class or description of foreigner, for prohibiting, regulating or restricting the entry of foreigners into India or their departure therefrom or their presence or continued presence there-in.

3. If you are not satisfied with the information furnished, you may file an appeal to Shri V. Vumlunmang, Joint Secretary (Foreigners) & Appellate Authority, Ministry of Home Affairs, Foreigners Division, NDCC-II Building, Jai Singh Road, New Delhi within the prescribed time limit.
