It is submitted that the Ministry of Home Affair is very keem interest in extending the benefits to Border Security Force personnel at par with Army/Air force/Navy considering the nature of their duties for which the MHA has issued several directions to the State Administration after the declaration of retired BSF personnel as 'Ex-Servicemen'. However, the State Administrations are not taking any interest im extending such facilities to BSF personnel as per the existing facilities extended to the defence force personnel because of the reasons that there was no amendment made in the Ex-Servicemen Rules after declaration of retired BSF personnel as Ex-Servicemen vide MHA order No. 27011/100/2012 dt 23/11/2012.

The State Administration is asking to provide copy of orders published by way of Notification in the Gazette of India to extend the benefits to BSF Ex-Servicemen.

It is, therefore, requested that MHA order No. 27011/100/2012 dt. 23/11/2012 may kindly be published in the Gazette of India to enable retired BSF personnel to approach State Govt. for getting their benefits as extended to the Ex-Servicemen of defense force personnel at the earliest.

It is further submitted that MHA has issued clear cut direction to the State Secretaries for extending certain benefits to BSF personnel after completion of Indo-Pak war in 1971 vide L/No.9/54/74-Estt/77 dated 22nd/24th June 1976 in which they have invited attention of MHA letter No.11/3/72 dated 22nd January, 1972 and No.22/11/72 Estt/BSF dated 20th Sept 1972. The copies of above letters are not available with this office. Kindly provide copy of said letters/orders to this Association to enable this office to pursue the matter with concerned State Govt. for speedy extending of benefits to retired BSF personnel since the condition of BSF Ex-Servicemen are worsening day by day.
