

The information is scattered among several public authorities. The application is also being forwarded to designated CPIOs of this Ministry for furnishing available information. In case the information relates to any other public authority, it is requested that the application may be further transferred to that authority under intimation to the applicant.

Please refer to your application dated 23/04/2014 under the RTI Act, 2005 which was received in this Ministry on 29/04/2014 by ~~transfer~~ from It is mentioned in this regard that as per the RTI Act, 2005 & Right to Information (Regulation of Fee & Cost) Rules, a request for obtaining information under sub-section (1) of section 6 of RTI Act, 2005 shall be accompanied by an application fee of Rupees Ten by way of Cash against proper receipt or by Demand Draft or Bankers cheque or Indian Postal Order payable to the "Accounts Officer" of the public authority from where information is being sought.

2. The following deficiencies were observed in your above-referred RTI application:

- (i) The fee of Rs. 10/- has not been remitted, which is mandatory for all applicants other than those in the Below the Poverty Line (BPL) category.
- (ii) The fee has been remitted by way of Court Fee Stamp(s), Non-Judicial Paper/Account Payee Cheque/Postage Stamp(s) which is not a valid mode of payment of fee under the Act.
- (iii) The Demand Draft/Indian Postal Order has been furnished for an amount of Rs./-, which is not the fee prescribed under the Act.
- (iv) The Demand Draft/~~Indian Postal Order~~ furnished is not in favour of the correct authority. It should be payable to the "Accounts Officer, Ministry of Home Affairs".

3. In view of the above, your RTI application along with the ~~DD/Demand Draft/Cheque/Non-Judicial paper/Court Fee Stamp~~ (No. 643087) for Rs. 10/- is returned in original.
