

Introduction: Hindi is not permissible in the Supreme Court of India and high courts of many states and ordinary citizen of India is not allowed to get justice in Hindi which is our national language or regional language even after 65 years of independence. We have limited permission to use Hindi in the high courts of few states only.

Please provide me following information by speed post or registered post:

- 1. Dates when permission was granted to Rajasthan, Bihar, U.P. and M.P. for use of Hindi in high courts of their states.
- 2. Reason for granting permission in each of the above states.
- 3. Dates when Tamil Nadu, West Bengal and Chhattisgarh sought permission for use of their regional language in their High Courts and reason for rejection in each case.
- 4. Any other state which requested for such permission to use Hindi/regional language. Please provide me details of permission or rejection.
- 5. All correspondence, file notings, notes, extracts etc. in connection with permission for use of Hindi/regional language in their respective states.
- 6. Complaints/representation received by the ministry/department till date for not using Hindi/regional language in the Supreme Court of India or High Courts of states.
- 7. Action taken on my representation dated 05.06.2013 for allowing use of Hindi in the High Court of Delhi (copy enclosed).
